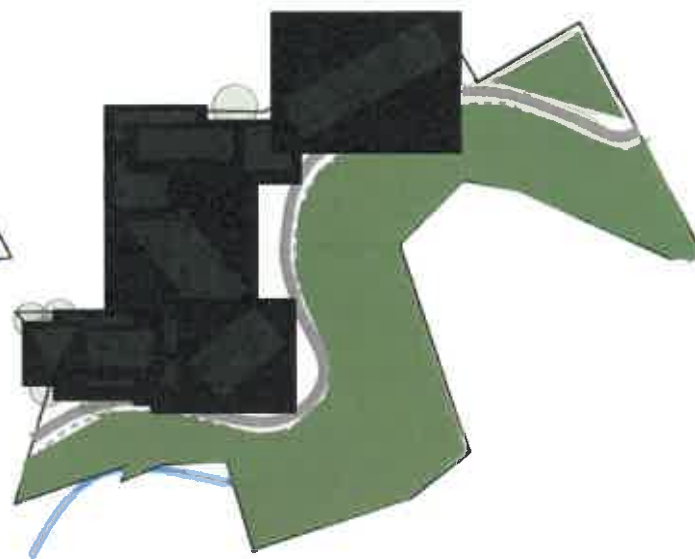
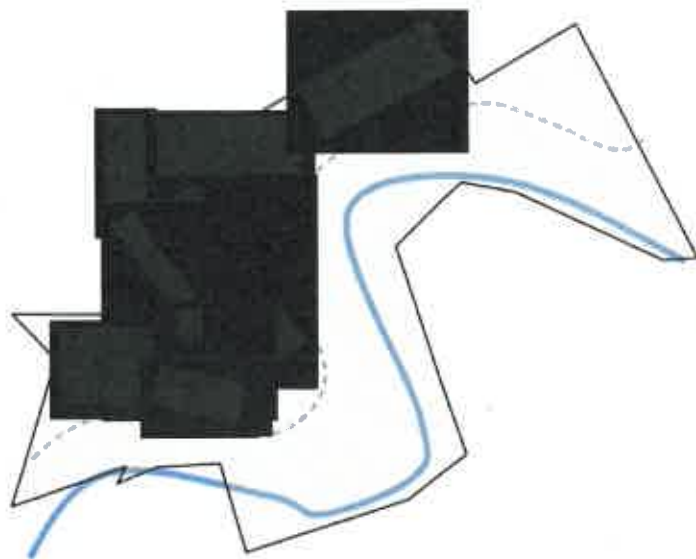
Please accept our petition and consider the community's urgent appeal to not allow project PLN2019-00024 or to drastically reduce its development intensity as required by laws, ordinances, policies, and goals, including the Castro Valley General Plan Biological Resources Overlay Zone and the community's dire need to preserve natural urban open space. The plan covers the majority of the site with parking lots.

Community calls the site Ruby Meadow. It is former public Caltrans 238 land taken for the purposes of a freeway plan that was ultimately cancelled after over fifty years. Ruby Meadow is most valuable to Alameda County as a healthful community open space asset and it is used as such on a daily basis. Ruby Meadow is the last natural open space along the San Lorenzo Creek before the waterway is channeled by concrete for the rest of its trip to the SF Bay. Wildlife gathers at Ruby Meadow, sleeps here, forages for food here, and the public gains peace, joy, and education by viewing the riparian wildlife habitat here.

Eden Housing gained ownership rights outside the public eye and has changed lot lines to evade environmental protections. Previous neighbors were never offered back their land that was taken for the cancelled 238 freeway bypass. Community never was afforded time to discuss what should happen to the land post-Caltrans, not even at the time the Castro Valley General Plan was written; instead the General Plan Zoning Implementation Process that is occurring now will change the zoning and ordinance that applies to the former 238 land. The Alameda County Housing Authority and Caltrans passed ownership rights to Eden Housing, Inc, a private non-profit, who claims they can "do what they want because they own it." Yes, Eden Housing may have ownership rights, but they are going beyond what policies, ordinances, and the General Plan say they can do.

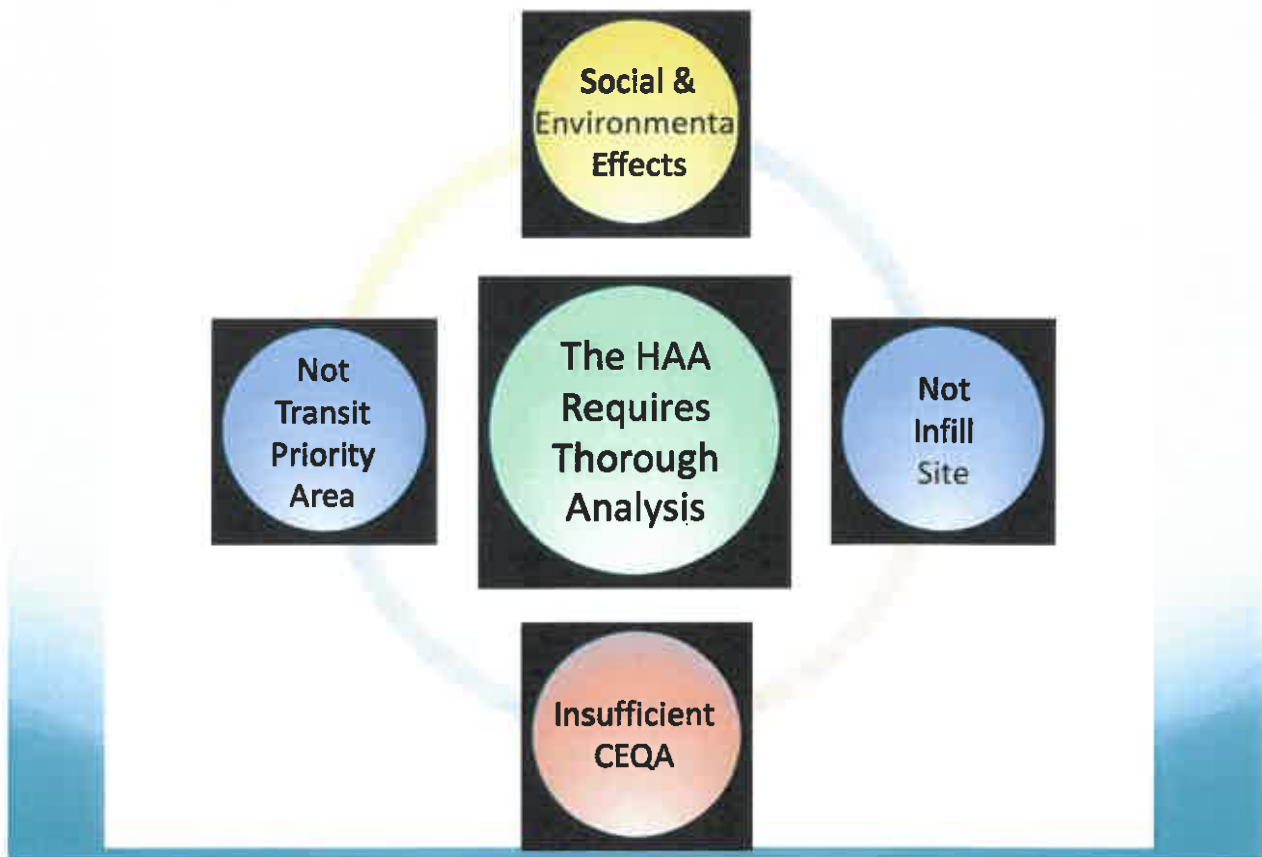

While some experts paid for by Alameda County and Eden Housing, Inc. ridiculously claim that absolutely no impacts will occur to the environment or to the existing neighborhood, any reasonable person and many community experts continue to claim this project will permanently devastate the existing neighborhood and will not well serve potential tenants. *Over a thousand* new housing units are being built nearby and yet no new parks are being added to our neighborhood of Southern Castro Valley, although Hayward Area Parks and Recreation District recognizes our severe park deficit. County data shows that our neighborhood, compared to all other Alameda County neighborhoods, has among the shortest life expectancies, the highest concentrations of seniors, disabled, and children, and a failing school district. There are no sidewalks or close transportation, defeating the purposes of the Housing Accountability Act. Increasing automobile congestion where residents are walking in

the streets is a recipe for disaster. The project's 55-ft tall building is more than double the height of adjacent tenant buildings whose sunlight will be blocked and is closer to them than standards allow, increasing the project impacts beyond what is acceptable.

The Housing Accountability Act Does Not Force Approval



What is best for Alameda County and the local community is to protect and improve this open space asset and to bring out and honor its Ohlone and European history. Many blighted and vacant lots are nearby that need development. It is immoral, if not illegal, to permanently remove a healthful asset when there are obvious alternatives. The Alameda County Parks, Recreation, and Historical Commission agrees.

Appendix A below contains some of the policies, ordinance, and laws we claim that the project is specifically violating and PLN2019-00024, as it sits, should not be allowed on this particular

site. Please also see the previous letters from all the below-signed community organizations and the public input for additional facts. Appendix B is the petition.

BIOLOGICAL**Reduce Development Size to Protect Woodland and Wildlife Corridor**

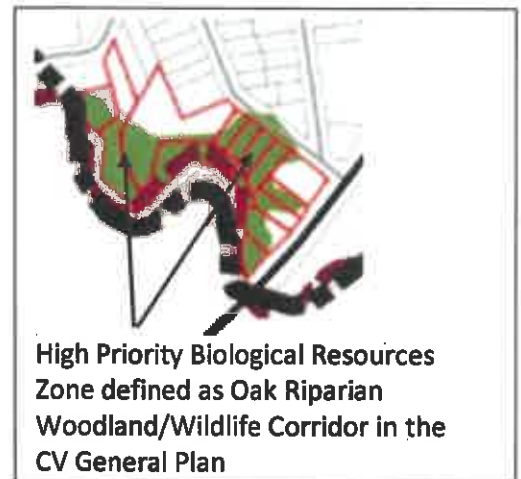
The CEQA Checklist incorrectly assesses biological resources and density reductions and does not comply the GP's Action 7.1-1 to reduce development intensity by up to 50% on lands with biological resources.

The project instead increases development density above that which is allowed by the underlying zoning. Biological resources are incorrectly assessed and not protected under the proposed plan, including: destruction of major stands and 87 (or 90%) of existing mature native and non-native trees outside the minimum setback, destruction of habitat particularly suited to special status bat species, and minimization of the width of the riparian corridor. This corridor is the San Lorenzo Creek "oak riparian woodland and wildlife corridor" that is considered "sensitive habitat" under the GP. The sensitive habitat that would be destroyed by the proposed project is in Parcel A and is beyond the habitat that is already protected by the minimum creek setback and existing conservation easement.

- **Zoning, Biological Resources, and Housing Density Reduction. The County's CEQA analysis does not correctly assess, and the project does not comply with action 7.1-1 of the CV General Plan, which states: "On lands with biological resources, new development is not necessarily entitled to achieve the maximum density allowed by the underlying zoning. Development intensity may be required to be reduced by up to 50 percent of the intensity allowed by the underlining zoning..."**

- **Prohibit Development on Half of Parcel A with Woodland.**

The County's assessment prohibits development only on Section C which is already protected by the minimum creek setback and existing conservation easement. The County needs to prohibit development on Parcel A where the "Oak Riparian Woodland" also forms the "Wildlife Corridor" (i.e., about half of Parcel A) as defined by the General Plan, and then reduce the allowable number of units and associated parking accordingly (from 72 units to ~36 units, and from 109 parking spots to ~55 spots). Development prohibition would apply to about half of Parcel A in order to satisfy CVGP Action 7.1-1 and the CVGP EIR requirements.

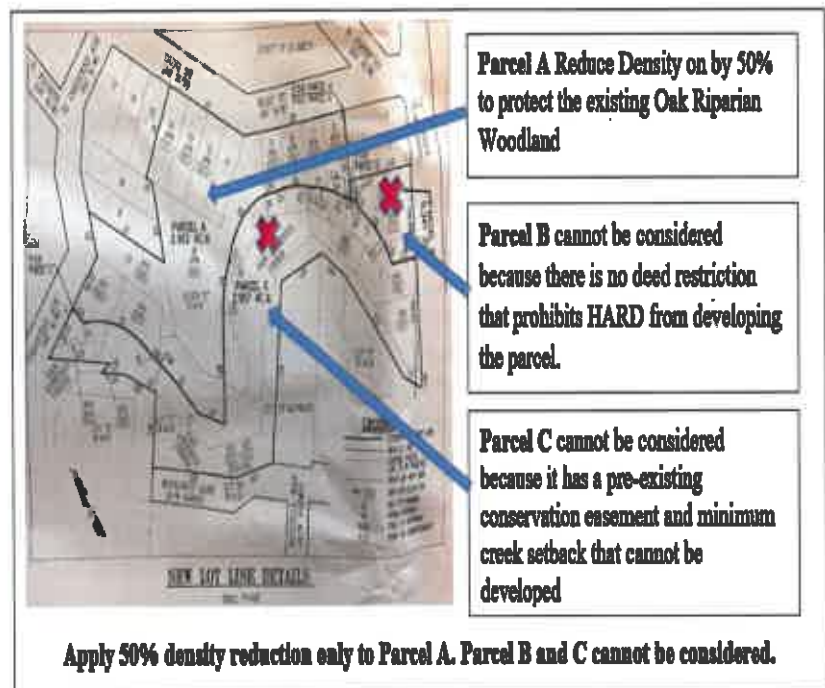


o Apply Density Reduction Only to Parcel A

The CEQA Checklist (p. 49) Improperly uses the site’s entire 6.3-acre total area to conclude that the project has reduced density and complied with Action 7.1-1.

When applying Action 7.1-1 of the General Plan, only the parcel on which the housing project would be built (Parcel A which is 2.95 acres) can be considered. The other two noted parcels that makeup the remainder of 6.3-acre total cannot be considered because:

- The 2.987 acres of Parcel C already have a pre-existing creek-setback and Caltrans-mitigation requirement to be a permanent conservation easement and therefore can never be developed. In addition, some previous parcels in Parcel C are zoned as Open-Space Natural.

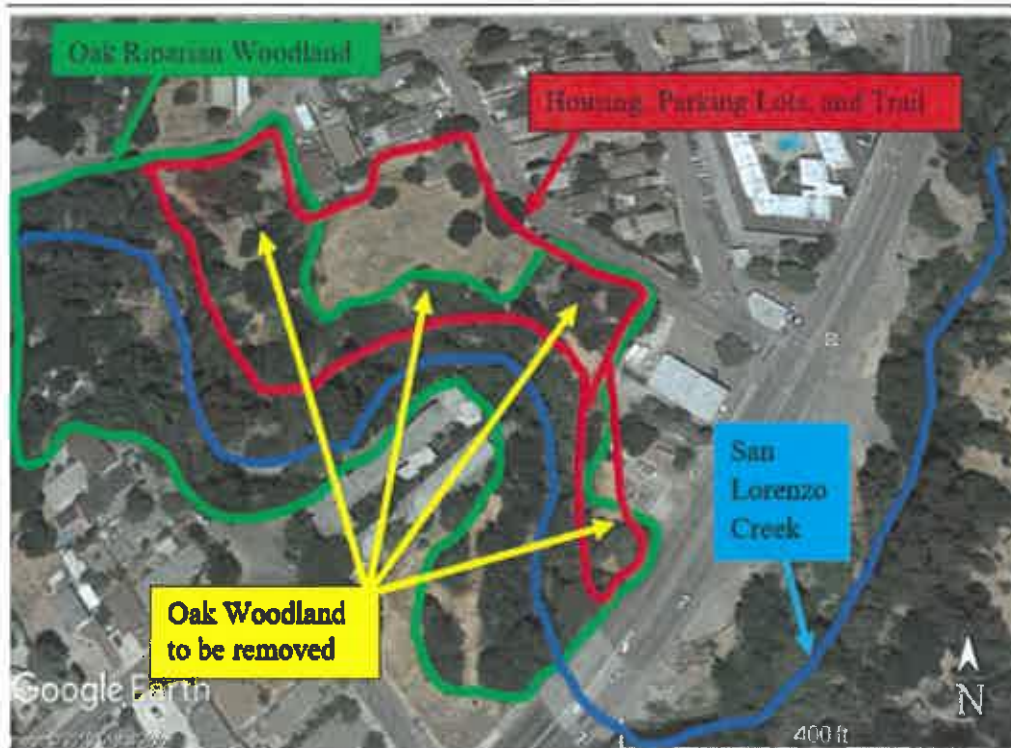


- The 0.341 acres of Parcel B could only be considered if a deed restriction is placed on Parcel B that prohibits future development.

- Oak Riparian Woodland

The CEQA Checklist (p. 49) improperly limited trees to be protected to only trees that provide a contiguous canopy over the creek. These canopy trees are already protected by the minimum creek setback. Other stands of trees beyond the minimum setback are also protected under GP policies because they meet the GP’s repeated description and policies of “Oak Riparian Woodland and Wildlife Corridor” and “Sensitive Habitat Area.”

- Actual Woodland Present. Aerial photographs and a citizen tree survey show that a third to half of the area proposed for development (i.e., Parcel A) is covered by tree canopy which forms the “Oak Riparian Woodland and Wildlife Corridor” and “Sensitive Habitat Area” described and identified in the CV General Plan and its Biological Resources Overlay Zone. Many of the areas with oak and bay trees also meet the definition of a “Coast live oak woodland and forest” alliance in the Manual of California Vegetation.
- County and Developer’s Misleading Woodland Assessment and Tree Count. The County says in its CEQA Checklist that the trees beyond the 20-foot line are not riparian trees, but “upland trees,” even though these “upland” oak and bay trees are also present on the creek banks. The County also lets the consultants categorize the larger site as JUST weedy grass and trees, rather than looking at the tree species and their canopies to identify the locations on site where oak woodland is in fact present. In addition, the Plan L-4.1 claims that 55 trees of 135 trees will remain, but 80% of these trees that are reported as remaining are already protected from development because they are within the minimum creek setback and conservation easement.



- Tree Demolition

This project is not “...designed to preserve natural vegetation, biological resources, and stands of large trees to maximum extent feasible...” as stated in the EIR (EIR p. 2-30)

In fact, a tree survey conducted by citizens identified 40% more trees than the project reported in the plans. Within the development area, the proposed project will demolish an extensive number of trees (87 total trees or 90%), native trees (45 trees or 45%), and other woodland. About a third of these trees (31 trees or 32%) have diameters 2 feet or larger, 25 of these trees are planned for removal, and many would be considered heritage trees. - Special-Status Tree-Roosting Bats

This project and the County’s Implementation of required programs and policies do not reduce risk to identified special status bat species (i.e., western red bats) or their habitat (i.e., mature woodland) to less than significant as required in EIR Impact 3.5-5. The CEQA Checklist only claims that biologists will try to identify that bats are not roosting before their prime tree habitat is cut down.

Western red bats, a California Species of Special Concern, were identified by volunteer bat experts conducting acoustic surveys at the site. *This species is given the highest priority for planning and conservation actions by the Western Bat Working Group.* These tree roosting bats are known to differentially select the type and configuration of mature trees and a wide riparian corridor width, which matches closely to the habitat at Ruby Meadow.

- Prime Western Red Bat Habitat. The research on western red bats reports that western red bats are most prevalent in well-developed riparian zones that are AT LEAST 164 feet wide and support large, mature trees such as Fremont cottonwood, western sycamore, and/or valley oak within the Central Valley and elsewhere along major rivers and tributaries. These bats have also been observed using other non-native trees in these areas such as eucalyptus and fruit/orchard trees in these riparian zones. Loss and degradation of these zones is the primary threat to western red bats.

The trees outside the immediate creek area at the Ruby site include large mature oaks that could be providing important roosting habitat. Pierson et al. (2011) documented red bats roosting in valley oaks. Krauel (2009) detected red bats at larger parks in San Francisco that had greater areas of forest edge habitat. Furthermore, the upland trees and meadow provide a buffer area of natural habitat to the site. Red bats could also be foraging over the meadow and around these heritage oak trees. Polyakov et al. (2019) found western red bat activity to be 3.46 times greater around large oak trees than the surrounding areas. They also found that the larger the oak tree, the higher the bat activity.

Extensive Biological Resources and Sensitive Habitat, described as Oak Riparian Woodland and Wildlife Corridor in the Castro Valley General Plan, will be removed by the proposed housing project.

Some conclusions:

- Oak Riparian Woodland and Wildlife Corridor would be removed within the development area of the project.
- There are about 97 trees within the proposed development area. Of these 97 trees:
 - Ninety percent (87 trees or 89%) would be demolished by development
 - About half (45 trees or 46%) are native, and 37 of these trees are planned for removal. These trees are mostly Coast Live Oak and some California Bay and Coast Redwood.
 - About a third (31 trees or 32%) have diameters 2 feet or larger, 25 of these trees are planned for removal, and many would be considered heritage trees.
- Areas proposed for parking lots and storm water management have the highest concentration of trees.
- The Crescent Street area (parking lot and stormwater mgt) has 2 to 5 times more trees than the other areas, and the greatest concentration of native and largest trees (>24 inches). This area also steps down in elevation towards San Lorenzo Creek, possibly due past creek cutting-erosion.
- Past (130 years) and current human activity in the proposed development areas, including recent Caltrans mitigation project work, have removed undergrowth and prevented growth of native trees & ground cover.



- **Ruby Site Similarities with Prime Bat Habitat.** Tree species, maturity, and configuration on the Ruby site closely matches the reported prime western red bat roosting and foraging habitat. The Ruby site has the following similarities with prime western red bat habitat:
 - Mature Fremont cottonwood, western sycamore, and coast live oak on the creek banks;
 - Mature coast live oak and non-native trees (e.g., fruit and eucalyptus) in the area proposed for development; and
 - A well-developed riparian tree zone that is up to 210 feet wide.

- **Corridor Width Reduction Below Prime Bat Habitat.** This project proposes to reduce the width of the San Lorenzo Creek oak riparian woodland and wildlife corridor to 105-120 feet, which is significantly (~32%) less than the larger widths (i.e., 164-feet OR LARGER) that western red bats are known to differentially select as their prime roosting and foraging habitat.

- **General Plan Habitat Definitions Match Ruby Meadow**

The GP and EIR definitions (Sec 3.5) of vegetation types, wildlife corridors, and sensitive habitat areas match and protect the riparian, oak woodland, and sensitive bat habitat at Ruby Meadow.

See these GP and EIR definitions below:

- **Native Vegetation Types:** *“Native habitats include primarily oak/riparian woodland occurring along creeks” ...and coastal scrub.”*
- **Wildlife Corridors:** *“Oak riparian woodland, coastal scrub, and grassland vegetation serve as the primary wildlife corridors. Non-native dominant habitats also may serve as movement corridors when continuous with habitats supporting native vegetation”; and*
- **Sensitive Habitat Areas:** *“All areas supporting native vegetation or providing suitable habitat for special-status species are considered sensitive habitat areas, including oak riparian woodland and naturalized native trees that provide potential nesting habitat for bird species. Sensitive habitat areas also include streams and wetlands...”*

- Special Status Bats Trigger General Plan & EIR Policies.

The County's site development review, CEQA Checklist, and other County programs failed to assess or implement required GP policies, actions, and programs so as to reduce the impact on special status bat species or their habitat to less than significant (EIR Impact 3.5-5).

The GP EIR triggers *ten specific General Plan policies and actions* when special status bat species such as the western red bats are present. These policies and actions are listed below.

EIR Impact 3.5-5 Proposed General Plan Policies & Programs that Reduce the Impact

The Draft General Plan proposes establishment of a Biological Resources Overlay Zone to protect areas with substantive biological resources, such as creeks, hillsides, and riparian areas, by requiring special review of proposed development in the zone. Figure 3.5-1 of this EIR identifies the biological resource priority levels in the Planning Area. The highest priority resources would be waterways

, drainages, oak riparian woodland, permanent open space areas, and coastal scrub areas near creeks or large open space areas. Special review would be required for projects in high priority areas as well as for development on sites larger than two acres in moderate- and low-priority zones. Special review may involve environmental review, site plan and development review, and the application of board policy or ordinance requirements. Other policies and programs that would reduce the Plan's impact on special status bat species or their habitat include the Policies 7.1-1, 7.1-2, 7.1-3, 7.1-11, 7.2-4, 7.3-1, 7.3-2, 7.3-3, 7.3-4 and Actions 7.1-2, 7.1-3, 7.3-1.

Policy 7.1-1 Protect the County's major wildlife corridors that run through Castro Valley: (1) the corridor along the east Bay Hills in the forest and chaparral between major interstate highways; and (2) along streams, especially those with riparian vegetation. (Reference – Draft ROSA Policy RC-41, Protection of Wildlife Corridors)

Policy 7.1-2 Preserve a continuous band of open space consisting of a variety of plant communities and wildlife habitats to provide comprehensive rather than piecemeal habitat conservation for all of Alameda County. (Reference – Draft ROSA Policy OS-3, Contiguous Habitat Conservation)

Policy 7.1-3 Incorporate design features that minimize the impacts of development on biological resources in any development planned on or adjacent to high and moderate priority areas designated on the Figure 3.5-2, Biological Resources Overlay Zone (Reference – Draft ROSA Policy RC-24, Minimization of Biological Impacts)

Policy 7.1-11 Require that open space provided as part of a development project be designed to achieve multiple open objectives, including but not limited to: recreation,

scenic values, habitat protection, and public safety. (Reference - Draft ROSA Policy OS-11, Open Space Provided by Development)

Policy 7.2-4 Require new development to set aside sufficient right-of-way and setback areas to accommodate multi-use objectives for storm drainage, flood control features, recreation, habitat protection, and other appropriate uses. (Reference – Draft ROSA Program 6 – Require Setbacks)

Policy 7.3-1 Continue to implement the Alameda County Tree Ordinance to protect trees in the public right-of-way.

Policy 7.3-2 Ensure that new development contributes to the maintenance and enhancement of the community’s natural environment by preserving existing native trees whenever feasible, replacing trees on-site, and adding trees and other vegetation in the public right-of-way.

Policy 7.3-3 Promote the use of native tree and plant species in public and private landscaped areas.

Action 7.1-2 Establish a Biological Resources Overlay Zone delineating high, moderate, and low priority areas for habitat preservation, to ensure maximum protection of biological resources.

- Require discretionary review for all development applications on properties within the high priority biological resources overlay zone, and for large sites over two acres in size with moderate or low priority biological resources. Discretionary review could include one or more of the following: environmental assessment per the California environmental quality act; site plan and development review; and/or the application of Board policy or other ordinance requirements.
- Establish in the ordinance that on lands with biological resources, new development is not necessarily entitled to be built to the maximum density allowed by the underlying zoning. An environmental assessment may be required, prepared by a qualified biologist, which shall be the basis for establishing development constraints specific to the property in question. Development intensity may be required to be reduced up to 50 percent of the intensity allowed by the underlying zoning, depending on the extent and value of the biological resources on the site.
- Establish thresholds of review for different types of projects. For example, a comprehensive environmental assessment should be required for new subdivisions, whereas minor improvements such as fences or decks may be exempt from special review if they meet specific standards.

Action 7.1-3 Develop design guidelines for development projects about how to minimize the impacts of development on biological resources. Apply these guidelines through the Planning Department’s project review process. Include information about ways in which special-status plant and wildlife populations on private properties can be protected over

time. Specify that watercourses and areas dominated by native trees and shrubs be left undisturbed by development to the maximum extent feasible.

The County's site development review, CEQA Checklist, and other County programs are not consistent with GP policies (7.1-1, 7.1-2, 7.1-3, 7.3-2) and actions (7.1-2 and 7.1-3) required to reduce the impact on special status bat species or their habitat to less than significant (EIR Impact 3.5-5).

The proposed project does not:

- Protect the necessary width and continuity of San Lorenzo Creek's major riparian and wildlife corridor (Policies 7.1-1 and 7.1-2)
- Minimize the impacts of development on biological resources for development that is planned on and adjacent to the site's designated high priority biological resource areas (Policy 7.1-3). See this site's high priority biological resource areas in Attachment B.
- Contribute to the maintenance and enhancement of the community's natural environment by preserving existing native trees on the project site (Policy 7.3-2). See the site's data on the mature native and non-native trees.
- Use the site's identified and extensive high priority Biological Resources Overlay Zones for habitat preservation to ensure maximum protection of biological resources (Action 7.1-2)
- Reduce the development density by up to 50 percent based on the high priority biological resources that are present (Action 7.1-2)

In addition, the County has not implemented Action 7.1-3 that includes:

- Development of design guidelines for projects about how to minimize the impacts of development on biological resources.
- Application of these guidelines through the Planning Department's project review process. Inclusion of information about ways in which special-status plant and wildlife populations on private properties can be protected over time:
- Specification that watercourses and areas dominated by native trees and shrubs be left undisturbed by development to the maximum extent feasible.

Other Biological Factors Outlined by Law Group

Other biological factors are detailed in the attached letter from Jason Flanders at Aqua Terra Aeris Law Group. For example, this letter details:

- Many CEQA Checklist failures, some of which were detailed on previous pages in this appeal letter.
- Why this project is not entitled to a CEQA Exemption Checklist, as partially outlined below.

This Project Is Not Entitled to a CEQA Exemption Checklist

This project does not qualify for CEQA Community Plan Exemption Checklist streamlining because:

- The CVGP requires “special review” of this Biological Resources Zone (BROZ) site that would require site-specific considerations and mitigation measures, but...
- CEQA Guidelines (§ 15183(c)) state the Checklist is only available if previously-adopted and uniformly-applied development policies or standards are applied with a finding that these standards will mitigate the environmental impacts when applied to future projects.

Full CEQA review should be required, including consideration of alternative development locations.

Re: Appeal of Ruby Street Apartment Project

Dear Commissioners, Director Lopez, and Ms. Chuahan,

Please find the comments, below, submitted in support of the June 24, 2020 appeal of the Planning Director’s approval for this project.

I. The Proposed Project is Inconsistent with the General Plan, and General Plan EIR, and No CEQA Exemption is Available.

The proposed project does not qualify for the CEQA Community Plan exemption because site-specific considerations and mitigation measures would be required for the project. The Community Plan exemption is only available “if uniformly applied development policies or standards have been previously adopted by the city or county with a finding that the development policies or standards will substantially mitigate that environmental impact when applied to future projects.” (CEQA Guidelines, § 15183(c) [emphasis added].) Here, the proposed development would occur on land designated by the General Plan as a Biological Resources Overlay Zone (“BROZ”), for which the General Plan requires “special review of proposed development projects” that imposes tailored and site-specific mitigation measures, not measures of uniform application. (General Plan at 7-5.)

The special review process will: evaluate the actual value of the habitat on the property; establish site planning parameters to preserve the most critical and/or most sensitive habitat areas; and establish conditions of approval to protect special status species during construction and occupancy. The special review requirements should be proportionate to the scale of the development project and the amount of valuable habitat on the property. On larger properties with high priority biological resources, the special review should require a biological assessment by a qualified biologist. For small home additions, application of standard conditions during building permit review would be more appropriate. Development is allowed on parcels within the BROZ; however, the review process shall determine the level of development allowed and the design features



necessary to protect biological resources. In order to ensure the protection of resources, property owners may not necessarily be entitled to the maximum amount of development allowed under the zoning on BROZ parcels.

(Id. [emphasis added].) These are all very clearly site-specific considerations that must be uniquely tailored considering the project proposal, the site in question, and its unique biological resources. Indeed, implementing the BROZ, General Plan Action 7.1-2 states that, “to ensure maximum protection of biological resources,” the County will “[r]equire discretionary review for all development applications on properties within the high priority biological resources overlay zone, and for large sites over two acres in size with moderate or low priority biological resources.” No reasonable interpretation of the General Plan could construe these requirements as “uniformly applied development policies,” since they will result in different and unique and site-specific requirements each time and place they are applied.

In general, the Checklist fails to afford this site the environmental protections that the General Plan and BROZ should require. The General Plan EIR emphasizes that “[t]he highest priority resources would be waterways, drainages, oak riparian woodland, permanent open space areas, and coastal scrub areas near creeks or large open space areas.” (GP EIR at 3.5-21.) But far from treating this site as the “highest priority” remaining greenspace in the unincorporated area, the Checklist sanctions substantial *increases* in development intensity for this site above and beyond that evaluated in the General Plan EIR, and recommends avoiding any CEQA review for this proposed project. Full CEQA review should be required to meaningfully implement this General Plan policy, including consideration of alternative development locations. (See, GP Action 7.1-1 [“Discretionary review could include one or more of the following: environmental assessment per the California Environmental Quality Act; site plan and development review; and/ or the application of Board policy or other ordinance requirements”].)

Nor does the Checklist, nor the General Plan EIR, ever even consider effects to a species of special concern, the western red bat,¹ which has been identified at the site by a qualified biologist. The failure to even identify this existing environmental condition, nor assess the proposed project’s impacts to this special status species, renders the Community Plan exemption unavailable. Moreover, the Checklist appears to discount effects to special status species by repeatedly noting that no nesting sites were found, and by tailoring mitigation measures to attempt to avoid impacts to nests. However, the Checklist also notes that the proposed project area provides foraging grounds for special status species, yet fails to consider the loss of any foraging areas to be potentially significant. This contradicts the General Plan EIR, which does consider the loss of foraging ground to be potentially significant. (GP EIR at 3.5-8, 3.5-9, 3.5-25; see also GP EIR at 3.5-5 [“All areas supporting native vegetation or providing suitable habitat for special-status species are considered sensitive habitat areas, including oak riparian woodland and naturalized native trees that provide potential nesting habitat for bird species,” emphasis added].)

The proposed project would adversely affect riparian habitat, and according to the General Plan EIR, General Plan Action 7.2-7 would help to mitigate or avoid such impacts by requiring the County to “[w]ork with non-governmental organizations such as the Urban Creeks Council on stream protection and restoration efforts in order to support multiple use, community involvement, and resource enhancement.” Here, one such non-governmental organization commenting extensively on the proposed project is Friends of San Lorenzo Creek, which creek would be adversely affected by the proposed project, and pursuant to General Plan Action 7.2-7, the recommendations of Friends of San Lorenzo Creek should be given special weight. (See, Comments of Friends of San Lorenzo Creek, 2019 Nov. 25, and 2020 Aug. 3.)

Nevertheless, the Checklist fails entirely to apply any meaningful BROZ protections to the proposed project. For special status species, the Checklist requires only that *construction* impacts (not long-term protect impacts) be mitigated by a qualified biologist directing construction activities to attempt to avoid *nesting or roosting*; these mitigation measures fail to mitigate the loss of foraging habitat for special status species. (Checklist at 47-48.) This contradicts the General Plan EIR, which does consider the loss of foraging ground to be potentially significant. (GP EIR at 3.5-8, 3.5-9, 3.5-25.)

The Checklist does note that impacts to riparian habitat would also trigger BROZ protections, but the Checklist fails to meaningfully apply the BROZ protections, or other effective mitigation measures, to the riparian impacts. For example, the Checklist notes that “Trees that were mapped as riparian are those that are associated with San Lorenzo Creek and/or provide canopy cover over the creek,” and speculates that “CDFW often takes jurisdiction over upland trees that provide canopy cover over creeks and sometimes takes jurisdiction of adjacent upland trees that have contiguous canopy with riparian trees.” (Checklist at 49.) The Checklist fails to provide any indication of how the wildlife or water quality agencies would determine whether to “take jurisdiction” over such trees, what mitigation measures they would impose if they did, nor what mitigation measures—presumably none?—that would occur. This is simply incompatible with the requirements of the BROZ to ensure protection of this high priority habitat.

The Checklist does require 3:1 mitigation for some tree loss, but fails to specify that replacement trees will be like-for-like, nor placed in appropriate locations, nor that they will be maintained and viability ensured for an adequate period of time. (Checklist at 53.)

The Checklist notes that, under the BROZ, ‘on lands with biological resources, new development is not necessarily entitled to achieve the maximum density allowed by the underlying zoning. (...) Development intensity may be required to be reduced up to 50 percent of the intensity allowed by the underlying zoning...’ (Checklist at 49.) The Checklist offers a non-sequitur, however, that “[o]nly 2.95 acres of the 6.3-acre site would be developed and the building is proposed on the portion of the site farthest from San Lorenzo Creek, as close to the public right-of-way as allowed by the County development standards and setback requirements.” (Id.) The acreage and location of the proposed development are not relevant to the question of the number of units permitted as the development intensity, which the proposed project makes numerous steps to *increase* through combining parcels and then invoking a density bonus. Rather



than reducing the development intensity by up to 50%, the proposed project drastically increases the development intensity, and the Checklist makes no showing that the proposed project would comply with this BROZ safeguard.

In sum, the proposed project is not entitled to the Community Plan exemption because the BROZ requirements should be unique for each site. Nevertheless, the Checklist fails to comply with the BROZ requirement to “to *preserve* the most critical and/or most sensitive habitat areas,” including development inside of the minimum creek setback, conservation easement, and immediate creek tree canopy; loss of riparian woodlands; loss of foraging habitat for special status species; and uncertain and ill-defined mitigation measures.

II. The Proposed Project is Not Entitled to Incentives or Concessions as a Use by Right.

Counsel for developer Eden Housing argues at length, and unsuccessfully, that the proposed project must be exempt from CEQA review and conditions of approval by right. (S. Birkey Letter to N. Chauhan, February 5, 2020.) The effects of the proposed project, however, would be exacerbated by its request to eliminate open space per square footage requirements from the project. The effects of this proposed concession are not reviewed in the Checklist, which effects must be considered before being granted, calling into question the validity of the Checklist analysis as a whole. Even if the County determines any CEQA exemption applies, which it should not, protection of open space, riparian habitat, and biological resources consistent with the BROZ overlay should be ensured through design review of the proposed project.

Finally, the proposed project application appears to predate the effective date of the use by right statutes cited by the developer’s counsel, and none of the Government Code sections cited were in place when the Castro Valley General Plan, or Alameda County General Plan Housing Element, were adopted. Accordingly, the proposed project remains inconsistent with the General Plan, and the Government Code, and should be revised.

HISTORICAL

Ruby Meadow and the surrounding area should be considered a historical and cultural resource and an educational resource for the public. This site is rich with millennia-long cultural importance (CA-ALA-566 is eligible for federal status). Its neglected Alameda County history includes the Ohlone use of this specific area, the importance of the Knox tract and his impact on agricultural commerce and residential development, the Knox Water Works, the Hayward Steam Laundry, the Pow Wow Tree, and the 1776 Juan Bautista de Anza National Historic Trail where Native Americans were first sighted by de Anza at the San Lorenzo Creek.

CEQA Exemption Checklist

The CEQA Cultural Resources D, on the CEQA checklist as well as N, Tribal Cultural Resources were insufficiently analyzed:

The CEQA states several times that “a Registered Professional Archeologist performed a records search at the NWIC, as well as a focused review of pertinent archeological, historical, and environmental publications. The archeologist also conducted pedestrian surveys”, but the document never identifies the archeologist or their credentials. I have to argue that a pedestrian survey is not indicative of what lies beneath nor adequate enough to base these conclusions and if in fact they researched pertinent archeological publications, they would have come to a different conclusion.

The CEQA goes on to state: “This background research determined that there are no recorded archeological resources in the project site. Archeological excavations conducted in 2014, as well as site surveys conducted for the project, did not identify deposits associated with P-01-001795/ CA-ALA-566”. This is not a factual statement. The ALA-566 dig uncovered numerous artifacts within 30 feet of the project’s proposed parking lot on Crescent Avenue.: “the presence of a well dated mid-holocene deposit is especially significant due to the rarity of such finds”. A 1997 newspaper article (which is referring to ALA-566 dig) confirms not only sites from 500-600 years old, but also a campsite estimated to be 5000 years old. The newspaper article and the ALA-566 document also refer to, two Native American grave sites being found in the late 1930’s.

In the CEQA, under N, Tribal Cultural Resources, it states that a list of tribes who have requested notification in the project’s vicinity were notified on behalf of the County to the tribes on the list. They also state that no responses were received within the statutory 30 day period of time. **Two Native American descendants, Andrew Galvan and Vincent Medina have come forward at the 8/3/2020 Planning Commission hearing to object that they should have been notified and were not.**

While we don’t doubt that the letters were sent to the Tribes, the letter states, “has determined that the likelihood of the P-01-001795/CA-ALA-566 extending into the Project Site

is extremely low". We contend that this is not accurate. There have been numerous digs in the past in this area. When considering widening A St, it is stated that 3 sites are located within 1 mile of the project site (A St.). The three digs are ALA-58, ALA-60 and ALA-412 (Historic Property Survey Report HPSR 1989). The Cultural Resources Review (CRR) 2001 document also goes on to indicate, "The majority of the City of Hayward has been designated as within areas of high and moderate sensitivity for archeological resources, but the city has several selected areas designated as *extreme* (Quaternary Research Group 1976). The extreme areas in the city of Hayward are located in the vicinity of A Street, and Winton Street and north and south of Tennyson Road west of Interstate Route I-880."

The ALA-58 dig had at least two burials (CRR page 19). This dig is calculated as ½ mile from ALA-566 dig (30 feet away from the proposed development). There were 2 bodies found at the 1238 A St. dig. These were accessioned in the Phoebe A. Hearst Museum at the University of California. The ALA-60 dig is "one of the oldest archeological sites excavated in the Bay Area, dating from at least the lower Archaic (4630/5530 BC)". This site has been "determined potentially eligible for inclusion National Register Historic Pales in 1981 (USNPS 1989b). We believe that if the letter was more forth coming regarding past digs, the discovery of several bodies at different locations, the fact that the proposed site falls in Hayward "extreme" area, and the fact that ALA-60 is potentially eligible for inclusion on the NRHP that Planning Department would have received a response and that the response would have been opposed to the development.

Document attached 4.4 (from 2009 Route 238 Bypass Land Use Study) references P-01-001795 states "indicate the presence of one Native American archeological site within the Project area, this P01, a large former settlement that includes burials.

Ruby Meadow is 30 feet away from the ALA-566 dig, the bottom border of the dig was Crescent Ave. The Crescent Avenue driveway location and proposed paved parking lot with 71 spaces, may very well obscure the artifacts from future analysis, as some of them are quite deep and may not be located during construction. We contend that this is not a "might find remains" situation that there is definitely archeological evidence in Ruby Meadow. The CEQA states "In most cases, archeological sites that are found to be significant (e.g. eligible for listing in the California Register) would qualify as "historical resources" under CEQA". It stands to reason that Ruby Meadow would qualify as both a Cultural Resource as well as a Historical Resource.

As further evidence, The Ohlone were hunter gathers (see attached newspaper article from 1978), "During the harvest seasons, most of the tribe migrated from the main village site and set up camps near the coast for shellfish, by the rivers for salmon, near marshes for ducks and geese, in oak groves for acorns. See next attached article stating: In addition to acorns, the Ohlone gathered and roasted a number of different plant seeds, and ate the nuts of the buckeye tree. The ALA-566 document quotes "riparian vegetation remains in the creek channels and numerous oak, bay, pine and redwood trees are present". Because the Creekside location, with a flat plateau, is a typical landscape where Ohlone performed daily functions like harvesting food, preparing food, health and cleanliness activities, and religious ceremonies it

stands to reason that even closer to the creek was also part of their camps during the harvest season, which is the Ruby Meadow area.

These impacts were not analyzed as significant in the EIR, but they are significant because of site specific conditions including the adjacent ALA-566 site. A valuable Ohlone resource will be obscured or removed, which negates any future value as a teaching resource, or as a local history and cultural resource. The CEQA Conclusion for both D, Cultural Resources and N, Tribal Cultural Resources are listed as less than significant, which the facts do not support, indicating that this project requires a full EIR review and is not eligible for the CEQA exemption.

The Eden Area General Plan Policies

page 3-53 P2 states, "To the extent possible, the County shall cause no substantial adverse change in the significance of a historical or archeological resource as defined in 15064.5 of the California Environmental Quality Act (Title 14. California Code of Regulations) through its direct or indirect actions."

Page 3-53 P3 states, "To the extent possible, unique paleontological resources, sites or unique geological features shall not be directly or indirectly destroyed or significantly altered."

Page 3-53 P4 states, "The County should make the Eden Area a top priority when conducting historic and cultural resources inventories in the county."

Page 3-53 P5 states, "Potentially significant historic resources may be defined as those resources identified in professionally prepared surveys or where additional evidence suggests that the property or structure may be significant."

The Castro Valley General Plan

Chapter 2 Vision of Castro Valley 2025

Page 2-6, Number 4 states, "While there are few "historic resources" eligible for listing on the State and Federal registers, there are some resources that can be preserved or enhanced to retain a connection with the community's historic rural character."

Chapter 3, Community Development Strategy

Page 3.9 states, "Maintain the character of the existing neighborhoods when allowing in fill with home additions and secondary units. There is no need for major increases or decreases in allowed density, except in cases where there are significant biological resources on the property. *There are significant biological resources in Ruby Meadow, as outlined above*

Castro Valley General Plan Draft EIR

Castro Valley General Plan Draft EIR, Project Description, Chapter 2 states, “Preserve the area’s defining natural characteristics, embodied in the hills, canyons, creeks, and rural corridors, and views to those natural areas. Update policies to reflect the passage of Measure D, which established an Urban Growth Boundary limiting urban development in most of the rural areas of the county, including the Canyonlands surrounding Castro Valley.

2.3 Proposed General Plan, Key Initiatives, 1

1. Valleys, Creeks, Canyons, and Hillside Preserved

Establish a framework of legal, managerial, and operational protections for the community’s natural resources, including the valleys, creeks, canyons, and hillsides, as well as views to those resources. Ensure that there is ongoing stewardship and maintenance.

2.5 Key Policies of the Proposed Plan, Residential Development, states, “Lot sizes shall be consistent with desired character of the area, as established in new General Plan land use classifications. Subdivision plans shall be designed to avoid areas that are environmentally sensitive, or have high fire hazards or steep slopes.

Chapter 3, Community Character and Design

This chapter proposes goals and policies that are intended to protect and enhance the elements of Castro Valley’s natural and built environment that define the community’s visual character.

4. Protect historic sites and structures and other cultural resources that help to maintain the special character and identify of Castro Valley and represent important physical connections to the community’s past.

The key policies the Plan proposes to achieve these goals are:

Protect and preserve federal and State-designated historic sites and structures and properties to the maximum extent feasible and establishing appropriate strategies to protect local cultural resources that do not qualify for designation as historic resources but still reflect Castro Valley’s history and traditions.

Biological Resources, states,

This chapter addresses the protection and enhancement of Castro Valley’s significant biological resources, which are concentrated in creek corridors, canyons, and hillside open space areas set aside as part of planned developments. The specific goals are to:

- 1. Protect and enhance native wildlife through conservation and restoration of a continuous network of connected natural habitat.**
- 2. Preserve creek channels and riparian habitat to protect and enhance wildlife corridors, flood protection, and the quality of surface water and groundwater.**
- 3. Maintain, preserve, and enhance trees and vegetation to provide habitat and protect the natural environment.**

To achieve these goals:

- Design guidelines for property within or adjacent to the proposed Biological Resources Overlay Zone.
- Discouraging loss of riparian woodlands and wetlands by requiring replacement mitigation.
- Encouraging agencies responsible for public infrastructure to design and build projects to protect wildlife corridors, creeks, and regional trails.
- Requiring that open space for new development be designed to achieve multiple objectives including recreation, scenic values, habitat protection, and public safety.

Chapter 3, Settings, Impacts and Mitigation Measures, Regulatory Setting, Specific Plan for Areas of Environmental Significance (SPAES)

This creates a Site Development Review process for designated areas of environmental significance. These areas are those throughout the county in riparian areas—where a watercourse forms the environmental focal point—and along the scenic route corridors identified in the County’s Scenic Routes Element. The specific plan is concerned with development guidelines and does not regulate permitted land uses. The County’s upcoming new Resource Conservation, Open Space, and Agriculture (ROSA) elements, described below, will replace this plan.

Action 4.9-10 Rezone properties to residential use on the southerly side of Grove Way east of Center Street, since residential uses already predominate in this area and residential uses can enjoy the visual and open space benefits of the creek to the rear.

3.5 Biological Resources, Sensitive Habitat Areas

All areas supporting native vegetation or providing suitable habitat for special-status species are considered sensitive habitat areas, including oak riparian woodland and naturalized native trees that provide potential nesting habitat for bird species.

Alameda County General Plan - Resources, Open Space, and Agriculture (ROSA) elements

The existing Alameda County Resources Conservation Element (1994) requires the County to locate uses or development that would seriously impact or jeopardize biological resources away from areas with significant biological resource value. The RCE requires the County to prioritize the preservation of lands that should be left substantially undeveloped including riparian habitats, habitat of rare or endangered species, and wetlands supporting concentrations of waterfowl. The RCE also requires the County to encourage the protection and restoration of sensitive and rare habitat types, including native grasslands, riparian woodlands, and oak woodlands, and to designate Sensitive Habitat Areas (SHAs) as a way to protect unique resources from development. The RCE also proposed that all SHAs were to be reclassified to Resource Management district.

Proposed General Plan Policies and Programs that Reduce the Impact,

Policy 7.1-3 Incorporate design features that minimize the impacts of development on biological resources in any development planned on or adjacent to high and moderate priority

areas designated on the Figure 3.5-2, Biological Resources Overlay Zone (Reference – Draft ROSA Policy RC-24, Minimization of Biological Impacts)

Policy 7.1-8 Protect all creeks and flood channels that traverse the urbanized area of Castro Valley, because they serve as movement corridors for wildlife. (Reference – Draft ROSA Policy RC-43, Water Channels as Wildlife Corridors)

Policy 7.2-1 Encourage protection of streams and adequate stream buffers to maintain and where appropriate enhance important stream functions, including: flood protection, recreational corridors, wildlife movement corridors, wildlife habitat, and aesthetic resources. (Reference – Draft ROSA Policy RC-7, Stream Protection)

3.12 Cultural Resources

For analytical purposes, cultural resources are typically divided into three categories: archaeological resources, historic resources, and contemporary Native American resources. Archaeological resources are places where human activity has measurably altered the earth or left deposits of physical remains. Archaeological resources may be either prehistoric (before the introduction of writing in a particular area) or historic (after the introduction of writing). The majority of such places in this region are associated with either Native American or Euro-american occupation of the area. The most frequently encountered prehistoric and early historic Native American archaeological sites are village settlements with residential areas and sometimes cemeteries; temporary camps where food and raw materials were collected; smaller, briefly occupied sites where tools were manufactured or repaired; and special-use areas like caves, rock shelters, and sites of rock art. Historic archaeological sites may include foundations or features such as privies, corrals, and trash dumps.

Environmental Setting

Historic and cultural resources include buildings and neighborhoods of historic architectural significance, places of special historic or archaeological interest, and other features that have special value to the community. In the following sections, the terms prehistoric resource, archaeological resource, and Native American resource are used synonymously, referring to a type of resource that dates back to pre-Euroamerican contact.

Physical Settings

Archeological Resources

Native American cultural resources in this part of Alameda County have been found on ridges, mid-slope terraces, and adjacent to seasonal and perennial watercourses. The Planning Area includes the type of environmental settings and features associated with known sites. For this reason, there is a high likelihood that unrecorded Native American cultural resources exist in the Castro Valley Planning Area and that additional prehistoric-period archaeological resources could be identified as development occurs under the proposed Plan.

California State

The California Register of Historical Resources was established in 1992 by amendments to the Public Resources Code. The Register includes resources that are formally determined eligible for, or listed in, the National Register, State Historical Landmarks numbered 770 or higher; Points of Historical Interest recommended for listing by the State Historical Resources Commission (SHRC); resources nominated for listing and determined eligible in accordance with criteria and procedures adopted by the SHRC, and resources and districts designated as city or county landmarks when the designation criteria are consistent with California Register criteria. California Historical Landmarks (CHLs) are buildings, structures, sites, or places that have been determined to have statewide historical significance by meeting at least one of the criteria in the State law. The County Board of Supervisors or the City/Town Council in whose jurisdiction the resource is located and the State Historical Resources Commission must also approve the designation. California Points of Historical Interest are sites, buildings, features, or events that are of local (city or county) significance and have anthropological, cultural, military, political, architectural, economic, scientific or technical, religious, experimental, or other value.

Local

Alameda County has a 15-member Parks, Recreation, and Historical Commission that advises the Planning Commission and the Board of Supervisors on matters related to historic resources. The duties and powers of the committee include: promoting preservation of historic resources associated with the unincorporated areas of Alameda County; recommending that certain sites be designated as historic resources; advising on the administration of historic sites and landmarks; and advising on all matters relating to the historic and cultural preservation of the unincorporated areas of the County, in particular State and federal designations and registration of historical landmarks.

The Eden Area General Plan, The Castro Valley General Plan and the Castro Valley General Plan Draft EIR all echo the same message: preservation of riparian woodland areas, promote preservation of historic resources, protect creeks and movement corridors, prioritize the preservation of land that should be left substantially undeveloped, and maintain, preserve, and enhance trees and vegetation to provide habitat and protect the natural environment.

Not only does Ruby Meadow qualify for environmental preservation, but the cultural and historical aspects of Ruby Meadow also qualify for preservation. Per the information below, the Ohlone were prevalent in this particular area and there have been numerous digs, documenting their presence. Ruby Meadow was once owned by Knox, who had a huge impact not only on Castro Valley, but the area in general. Ruby was his daughter. He was instrumental in the development of commercial agriculture, he helped establish techniques for transcontinental shipment of fruit by refrigerated train cars, he was an inventor, and the first sub-developer of the Knox Tract. The Knox Water Works was developed on the Ruby site, by William Knox Jr. Not only was this the first piped water delivery system in Hayward, but the town was also provided with hydrants for fire protection. There is still physical evidence of the Water Works on the Ruby site. The Hayward Steam Laundry, was a thriving business on Ruby St. for over 50 years. The chicken hatchery building still sits at the corner of A Street and Ruby Street.

The de Anza Trail is already a federally recognized landmark. The trail went down our current Mission Blvd., which is a few blocks from Ruby Meadow. The Pow-Wow Tree is currently listed in the California inventory of Historic Resources (CAL-OHP 1976:224). The tree was located near 1399 A St. The tree was most likely disregarded and destroyed, but the site continues to hold its sacred value.

Historic Property Survey Report

Redwood Road – A Street Widening, Castro Valley, Alameda County, California for Public Works Agency, November 1989. This documents information before site CA-ALA-566.

6.0 Field Survey Methods and Findings

“The intent of an archival background review and a filed survey is to identify cultural properties including archeological sites, standing structures and arboricultural resources which may be potentially eligible for inclusion in the NRHP. Eligibility criteria for evaluation includes: (1) is at least 50 years; (2) retains integrity of location, design, setting, materials, workmanship, feeling, and association, and (3) has one or all of the following characteristics: (a) “.....with events that have made a significant contribution to the broad patterns of our history”; (b) “....with the lives of persons significant in our past”; (c) “....that embody the distinctive characteristics of a type, period, or method of construction, or that represent the work of a master, or that possess high artistic values, or that represent a significant and distinguishable entity whose components may lack individual distinction”; or, (d) “....have yielded, or may be likely to yield, information important in prehistory or history.” (US Office of the Federal Register 1988:246;CFR60.4). *Although Ruby Meadow, the surrounding digs and historical sites may not be eligible for the Federal National Register, we are confident that they should qualify for state recognition or local recognition, based on the above mentioned criteria.*

5.0 Background Review

5.1 Native American

“Three sites, CA-ALA-58, -60 and -412 are located within one mile of project in the San Lorenzo Creek watershed (after G. Miller 1982:61).

CA-Ala-58, an earth mound with at least two burials, mortars, and pestles, was discovered and destroyed as a result of construction (Davis 1959).”

This dig site was located at the end of Maple Court in Hayward at a depth of about 7 feet. This site is approximately ½ mile from the CA-566 dig site.

“In contrast, CA-ALA-60 has received considerable attention prior to the construction of improvements to Route 580. CA-Ala-60 is considered to be one of the oldest archeological sites excavated in the Bay Area, dating from at least the Lower Archaic (4630/5530 B.C.) and occupied intermittently through Phase 1 of the Late Horizon (c. A.D. 1500 terminus). The available data suggests that CA-ALA-60 was a large satellite activity site possibly linked to a larger bayshore village(s). Seasonally available vegetal and faunal resources from the local

riparian woodland/foothill environmental setting were exploited although task specific subsistence or activity areas could not be identified. This site was determined potentially eligible for inclusion in the National Register of Historic Places in 1981 (USNPS 1989b).” *The site is located with 1 mile of the CA-566 dig site and has already been determined potentially eligible as a Historic Site.*

“The last site, CA-Ala-412, is located at an elevation of 325 feet in the Castro Valley hills and appears to be limited to five pecked cupules on an isolated sandstone boulder.” *We have been unable to determine where this dig was, but again, within 1 mile of CA-566.*

CA-Ala-566 (dig site in 1997, 3rd & Knox St. in Castro Valley)

The 566 dig was done due to the CalTrans 238 proposed build. The location of this dig is 30 feet away from Ruby Meadow. We contend that what with the other digs that have been performed and the other burials that have been located, that Ruby Meadow has high potential that other unrecorded Native American and/or cultural resources exist within this area.

“There appear to be at least two components present. The upper component (20-60cm in depth) is represented by buried hearths found adjacent to N. 3rd St. between Knox St. and Crescent Ave., and a reported burial find from the 1930s at the corner of Knox and N. 3rd.”

“The site is especially interesting because the individual components represent very discrete periods of time, with the process which buried them serving to prevent conflation with later episodes. They appear to represent short term use of the riparian corridor for vegetal resources as opposed to a settlement site, although it remains a possibility that other more elaborate deposits are present in the vicinity. The presence of a well dated mid-holocene deposit is especially significant due to the rarity of such finds, as is the apparent similarity in function with the later component despite the separation in time.

1238 A St. (old Bank of America Bldg.) dig located two burials.

The bodies were accessioned in 1938 at Phoebe A. Hearst museum of Anthropology (UC/PAHMA) University of California (accession #500FG). (From research and 566 dig)
 “The majority of the City of Hayward has been designated as within areas of high and moderate sensitivity for archeological resources, but the city also has several selected areas designated extreme (Quaternary Research Group 1976). The extreme areas in the City of Hayward are located in the vicinity of A Street, and Winton Street and north and south of Tennyson Road west of Interstate Route I-880.” (From the Cultural Resources Review Archeological & Architectural Resources, City of Hayward, October 2001).

“The Costanoan-speaking groups in 1770 lived in approximately 50 separate and politically autonomous nations or tribelets. Alternatively, the San Lorenzo Creek watershed in the vicinity of Hayward was occupied by the Yrgin. The existence of this tribelet has been deduced from

Mission San Jose baptismal records dating between 1801 and 1805. (Milliken 1983:101, 139, Map 4). Historic accounts of the distribution of Costanoan tribelets and villages in the 1770s-1790s and the results of archeological efforts in the area suggest that a number of tribelets may have had temporary camps or possibly even relatively permanent settlements within the vicinity of the project area throughout the prehistoric period and into the Hispanic Period.”

Based on this all of information, it stands to reason that the Ruby Meadow site most certainly has evidence of Ohlone Indians; local Native Americans report that a village is known to have been located at the site.

ZONING & LAND USE

Castro Valley General Plan Zoning in the 238 Properties

Zoning and lot lines at the site are changing. At the time of the Castro Valley General Plan adoption by the Board of Supervisors (2012), most residents were unaware that the freeway had been cancelled in 2010 and that County zoning would now have relevance after fifty years of non-relevance. Public was not invited to partake in critical decisions: The community knows best and cares most for its residents and for the long-term economic and environmental stability of the area. It is negligent of the Planning Department to approve such a large development, with such extensive coverage, in an area of the highest priority biological resources.

2009 238 Land Use Study

The project background of the 8/26/19 staff report goes on to say that “*from 2007 to 2009, the County participated in the preparation of the City of Hayward’s Route 238 Bypass Corridor Land Use Study, which was funded through a Community-Based Transportation Planning Grant from Caltrans*”. The result of this publicly-funded study was an overall plan for the use of the 238 properties *in both Hayward and unincorporated County*. In 2009, the City of Hayward adopted both the study and the zoning changes necessary to implement the plan. The Ruby Meadow project site was designated to remain *open space*. Zoning reflects these decisions on the City of Hayward parcels of the Ruby Meadow project (possibly 415-230-69, 415-230-72, 415-230-73) but Alameda County zoning does not reflect the land use study’s recommendations and conclusions. When did Alameda County decide not follow the land use recommendations?

The 8/26/19 staff report concludes the project background section by stating, “*During this process, County staff sought input from the CVMAC regarding appropriate land uses for the unincorporated corridor parcels at public meetings, including a field trip to the properties*”. It is unclear to which process the report is referring, and the word choice suggests the process was the 238 Land Use Study. However, neither meeting nor field trip occurred prior to the 8/26/19 CVMAC. I believe and understand that the public meeting mentioned *was* the 8/26/19 meeting. The “*field trip*” took place on 8/19/19, the week prior to the CVMAC public meeting and was not a past action like the report suggests.

Route 238 Master Development Plan

The staff report describes that some zoning in 238 parcels will be increased, and some zoning will be decreased. County Planner Horrisberger explained to me that residents had not been notified of these zoning changes at the time of the Castro Valley General Plan because it was a large, overall change, and residents are only notified of smaller changes. The staff report cites the Route 238 Master Development Plan, which has never been revealed to the public, if it exists. The Hayward process seems to create Master Development Plans for each development area, not one Master Plan. The closest we have seen to a Master Plan is the 238 Land Use Study which is being disregarded by County Planning.

2015 County Housing Element and Zoning

The 8/26/19 CVMAC staff report discusses the 2015 Alameda County Housing Element (ACHE) and states that, within all 400 acres of the former 238 parcels, the Housing Element Sites Inventory provides capacity for 185 residential units.

Staff claims that *“If the permitted land use on any of these parcels were to change from residential to another use, or if the permitted density were to be significantly reduced, the County may be required to identify other properties within the Unincorporated Area that could be rezoned to a higher density to make up for the lost capacity to accommodate its RHNA.”* This is an absurd claim regarding zoning in the Ruby Meadow project because only 29 units are in the 2015 ACHE, which are easily made up by denser building in other neighboring 238 parcels which are not in the BROZ. Table 1 summarizes the zoning, land use, planning, and housing element data on the twenty Ruby Meadow parcels being combined by this project. **Only seven of the eleven parcels in the development area are in the 2015 Alameda County Housing Element.**

Combining twenty parcels into three new parcels, in effect, changes the BROZ designations, which in turn **changes the zoning to accommodate the project.** Housing density bonuses are inappropriate when zoning has been changed to accommodate the project and the Community Plan exemption is not appropriate because the project is not consistent with the Community Plan.

General plan elements are required to be consistent with each other. The seven state-required elements are land use, open space, conservation, housing, circulation, noise, and safety. The elements are not consistent with regard to zoning in the Ruby Meadow project. Ten out of the twenty project parcels are listed in the 2015 Housing Element. Their **Community Plan Designation is “unspecified”** and proposed to be residential medium density multifamily. The County zoning district of these ten parcels is R-S-D-20.

Five of the housing Element parcels are also located in the CVGP BROZ. **These five parcels in the highest priority BROZ are also the parcels on which the project places the majority of development, in the new parcel A.** Allowing construction and almost complete coverage in the

BROZ, and concentrating development in the highest priority BROZ, rather than outside the BROZ is inconsistent with the General Plan Goals, Policies, and the CVGP EIR.

The biological assessment was not thorough, for example no raptors were identified although neighbors have frequently photographed raptors around our homes, migrating birds were not evaluated nor discussed although we see egrets yearly in our neighborhood, no bats were identified although this is a prime location and bats have always been here, no discussion of the cumulative effects that has already caused the losses of steelhead and frogs was discussed, no discussion of biodiversity or impacts to the food web was discussed. CEQA code, Section 15183, requires the project requesting the streamlining exemption to be, “consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified.” The danger of following Actions instead of Goals and Policies is that changes are normally made during the implementation process. For example, an Action might suggest “50%,” but during the implementation process the specific percentage might be changed to 100% under certain circumstances. We just don’t yet know because the implementation process has not yet happened. Besides following existing laws and ordinances, the most weight should be given to the vetted Castro Valley General Plan Goals and Policies, or to Actions which have been already implemented, not to unimplemented Actions. Page 23 concurs that CEQA law requires the project to comply with policies identified in the General Plan EIR.

Page 96) Land Use and Planning, Criterion “I.” Although the County maintains that the project is consistent with the Castro Valley General Plan and zoning, the zoning on the site itself is, and has been, the subject of Phase I of the CVGP Zoning Implementation. County maintains that any zoning changes that may occur within the site a) have no relevance because the project is eligible for the zoning at the time of application, so changes won’t matter, and, b) the proposed zoning changes maintain the housing density, so the changes don’t matter. These arguments avoid the facts that community has not yet had a chance to weigh in on, or been informed of, zoning changes and plans that have been taking place at the project site and will consist of amendments to the Alameda County Ordinance. Community deserves a chance to weigh in on serious changes in land use as proposed on this Ruby Meadow site. These arguments ignore the fact that, recently, once neighbors were informed and included in the process, there was an overwhelming majority of community opinion that Ruby Meadow must be preserved as a biological, historical, and cultural resource. The land itself, its existing contents, and its current role are important to maintain the character of our existing neighborhood, a primary purpose of the zoning ordinance itself.

Criterion 1.a and 1.b: The CEQA document state that this site “is surrounded on all sides by urban development” which is not true. The Parks and Open Space zoning in at least two of the project parcels (415-230-72 and -73) is not discussed here.

The large building and extensive parking lots do conflict with the existing land use pattern which is primarily a single-family neighborhood with a few multi-family buildings and the H.A.R.D. Senior Center complex. This is a very quiet, peaceful, and nature-oriented location full of wildlife, which will drastically change with this development. The existing land use in the Castro Valley General Plan is “public” and community has not yet had a chance to participate in new uses for the land (see above general comments about inappropriateness of CEQA exemption). The CEQA document mentions that the land use compatibility will be reviewed later during the site development process, but the impacts to this neighborhood are peculiar to this project site, much more severe than described, and not fully disclosed in this CEQA document, and will cause multiple off-site impacts due to this project’s land use being much more dense and not in character with the immediately surrounding neighborhood. Changing the land use from low to no residents and extensive wildlife habitat to a dense and tall apartment building is a conflict with the existing land use pattern. The fact that other projects have been approved by the City of Hayward on the other (Hayward) side of the creek is not explained and is also not a reason to destroy this existing land use. It will cause severe impacts to the residents, the community, and to populations in neighboring communities which deserve the opportunity to observe nature and wildlife in its natural state.

For example, although the neighboring sites across Crescent Avenue are also zoned for higher density, development will not happen there due to its location of the Ohlone Site CA-ALA-566. These properties are also part of the current zoning implementation process. The trail proposed by this project is not along the San Lorenzo Creek as described in this section. The trail is proposed within the development of the new Parcel A which will not connect the public more to the creek, which is already fully accessible nearby. In addition, the meadow and creek area here are located in the CVGP Biological Resources Overlay Zone, because it is a sensitive environmental resource. The public trail location has not yet been determined in the General Plans and may instead be relocated to the street at this site due to trail standards and wildlife habitat. The project will divide existing community by removing and/or blocking from view the nature at the riparian habitat that is a valuable part of the community here.

Criterion 1.c: The Castro Valley General Plan EIR clearly says ROSA cannot be used in CEQA analysis because it does not yet exist (page 3.5-1). The CEQA incorrectly says in section 1.c that the project does not cause a significant environmental impact due to conflicts with the General Plan, Specific Plans, or the Resource, Open Space, and Agriculture Element (ROSA). ROSA has not yet been completed, so the current documents that must be considered are part of the Alameda County General Plan Open Space, Land Use, and Conservation Elements—1973 Open Space Element and 1977 Specific Plan for Areas of Environmental Significance (SPAES). Goals and policies in these two documents have neither been mentioned nor discussed in this CEQA exemption document. Portions of these two documents are found in the CVGP, but the CVGP does not supersede SPAES which is a current component of the Alameda County General Plan (General Plan Annual Report, 2017).

Specific Plan for Areas of Environmental Significance (SPAES)

The SPAES defines a riparian area as “the vegetation or wildlife dependent on or associated with any of” the riparian area definitions listed in the SPAES (page 8), which includes the San Lorenzo Creek riparian corridor. The CEQA and project documents incorrectly define that the grasslands and scattered oaks are not part of the riparian corridor, when these features are essential to riparian wildlife. The SPAES defines the riparian area as those components which form the environmental focal point.

The SPAES states that “The Riparian Area of Environmental Significance will normally be considered the demarcation line between the vegetation zones of wetland and upland” but will extend to other bodies of water so that all riparian vegetation is included. The difficulty with the definition of the riparian area is the project site is that cumulative damages have already occurred due to mis-use by fifty years of Caltrans management and urbanization beginning in the late 1800’s. These cumulative effects at this specific project site are not examined in the CEQA exemption nor the EIR. They are impacts specific to this site and are more severe than discussed in the EIR. The impacts to Ruby Meadow were not analyzed as significant but they are because wildlife, including migratory water fowl need not only the creek and its banks, but also the adjacent open space grasslands with scattered mature Oaks. Areas that can be restored and could support the required riparian biodiversity should be restored and conserved, not further degraded. In fact the CVGP EIR discusses the need for “replacement mitigation required for riparian woodland habitat and wetlands removed by development.” Why remove more sensitive habitat when our goals are to recognize and preserve these areas?

SPAES says that the procedures to protect habitat “will apply to all development totally or partially within these corridors.” By changing the lot lines and creating three new parcels out of twenty, the project developers are attempting to avoid and redefine the established BROZ. The policies, goals, objectives, and actions found in the CVGP and its related documents all support meaningful and productive land use. The CEQA exemption denies that this sensitive habitat exists at this specific site, it denies the importance and relevance of this specific site to the neighborhood, it denies that the site is the richest in our area for cultural, historical, biological resources. The site-specific features are mentioned but then disregarded as being significantly impacted by this project. The site-specific features are not thoroughly analyzed and will require a full EIR to understand the severity of the impacts.

The CVGP EIR lists significant impacts will occur if buildout proposed by the General Plan would physically divide an established community, which this project will by blocking and removing the usual presence of the Ruby Meadow and its wildlife in front of the creek that everyone sees as they drive by on Ruby Street.

The CVGP EIR lists significant impacts will occur if the type of land use is significantly changed; see CVGP Figures 4-1 (existing) versus 4-2 (proposed) which changes the “public” land use in Ruby Meadow to residential. These impacts are not examined. In fact, what development and what impacts will occur on the entirety of the almost 30 acres in our neighborhood of former Caltrans 238 properties are not examined nor described.

The CVGP EIR states that “the existing Alameda County Resources Conservation Element (RCE) requires the County to locate uses or development that would seriously impact or jeopardize biological resources *away* from areas with significant biological resource value.” The RCE requires the County to prioritize the preservation of lands that should be left substantially undeveloped. The RCE also requires the County to encourage protection and restoration of sensitive and rare habitat types, including native grasslands, riparian woodlands, and to designate sensitive habitat areas (which the CVGP may have done in designating the BROZ shown in Fig 7-2). If County ignores the efforts, plans, and purpose put into preserving and restoring sensitive areas, what was the purpose of pretending like it is important to do?

Over and over, in the CVGP, the BROZ is cited as the reason any impacts due to land use will be reduced or nonexistent (Page 3.5-21). The EIR recognizes the value of preserving creek areas because they serve as movement corridors for wildlife. The County and the developer suggest that wildlife does not need Ruby Meadow and the neighborhood will not be impacted if wildlife is constrained to the immediate creek setback. The EIR and CEQA do not discuss the effects of placing a large and tall development directly adjacent to sensitive habitat, and do not discuss whether this human activity will impact any wildlife that could use this valuable habitat space. This is not a vacant lot the project is proposing to develop on, although our neighborhood has many alternate sites which are vacant lots. An alternative site is not considered.

SPAES policy, which is currently in effect: Policy 4) If the environmental limitations warrant, most development may be prohibited in certain cases. This actual component of the certified General Plan supersedes the hypothetical 50% less development that may be required by the not-yet-implemented BROZ. SPAES Policy 8) The long-term preservation of natural and seminatural riparian areas and wildlife habitat shall be a guiding criterion In public decisions. Site Development Review implementation would not occur until the riparian corridor study was completed for any watercourse. This CEQA exemption does not rise to the level of a riparian corridor study, which might be accomplished as part of a full EIR.

Density Bonuses and Title 17 Zoning Ordinance

The density bonus laws and CEQA Exemption are used because the project location is “special”-in a sensitive biological area in a disadvantaged neighborhood and does not qualify for other programs such as SB35 streamlining. The site is not infill-designated in the Castro Valley General Plan (Figure 3-1) nor as defined for SB35.¹ The location is not near transportation, nor does the neighborhood have adequate infrastructure.

§65915(d)(1) The city, county, or city and county shall grant the concession or incentive requested by the applicant unless the city, county, or city and county makes a written finding, based upon substantial evidence, of any of the following:...(B) The concession or incentive would

have a specific, adverse impact, as defined in paragraph (2) of subdivision (d) of Section 65589.5, upon public health and safety or the physical environment or on any real property that is listed in the California Register of Historical Resources and for which there is no feasible method to satisfactorily mitigate or avoid the specific, adverse impact without rendering the development unaffordable to low-income and moderate-income households.

Climate Cooling Actions

Both the Alameda County's Community Climate Action Plan and the Cooling Our Communities project call for **more tree planting** as a reaction to the climate crisis and livability. This project is contrary to County goals and plans because it removes THE MOST DENSE TREE CANOPY in a neighborhood lacking trees overall.

Measure A1 Funding

On February 4, 2020, the Alameda County Board of Supervisors allotted ½ of unincorporated County's Measure A1 funding—almost 9 million dollars—to this project which is not a community benefit. Please compare to the project that was allotted the other half, which revitalizes brownfield land into parks, community amenities, and homes. That project is appropriately located near transportation and resources that can be accessed using existing sidewalks. The two projects are like night and day, providing another reason the disallow the substandard project. The Ruby Street project is not yet approved and does not meet the accessibility nor the neighborhood improvement requirements of Measure A1.

WHEREAS, Article XXXIV of the Constitution of the State of California (“Article XXXIV”) provides that no low-rent housing project shall be developed, constructed, or acquired in any manner by any state public body until a majority of the qualified electors of the county in which it is proposed to develop, construct, or acquire the project, voting upon such issue, approve such project by voting in favor thereof at an election to be held for that purpose, or at any general or special election **BALLOT MEASURE: ALAMEDA COUNTY AFFORDABLE HOUSING BOND**. To provide affordable local housing and prevent displacement of vulnerable populations, including low- and moderate-income households, veterans, seniors, and persons with disabilities; provide supportive housing for homeless people countywide; and help low- and middle-income households purchase homes and stay in their communities; shall the County of Alameda issue up to \$580 million in general obligation bonds to acquire or improve real property, subject to independent citizen oversight and regular audits?

---spent in accordance with the purposes set forth in the ballot measure. Pursuant to Government Code Section 53410, the following additional accountability measures will be complied with for this bond measure: **Specific Purpose:** The specific purpose of the bonds to be issued pursuant to this bond measure are to fund the acquisition or improvement of real property in order to prevent displacement of vulnerable populations, to provide supportive housing for the homeless, and to help low and middle income households purchase homes. The proceeds of any bonds issued pursuant to this bond measure will be applied only to these specific purposes.

The capital investment in housing made possible by the Bond will help to meet the needs of lower income seniors, people with disabilities, homeless, veterans, re-entry, youth aging out of foster care, and low-income working families, while also helping to stabilize existing neighborhoods and increase the livability in every community in the County. Increasing access to safe and affordable housing will, in turn, promote diversity, social equity, and economic vitality – cornerstones that support our thriving County.

Housing Affordability Act

The HAA purpose is to prevent local governments who block appropriate housing. Nothing in the Act says that environmental or social effects should be ignored; to the contrary, it specifically says the purpose of requiring more housing near jobs and transportation is to help meet the state's environmental and climate crisis goals by preventing the environmental consequences of residents' having to commute. Section 65008 regarding congestion management addresses infill development and transit-oriented development, which this project is not per that section, SB 35 definitions, and the Castro Valley General Plan.

CA GOV CODE §65913.4 (a)(2)(B) *"Infill" means "A site in which at least 75 percent of the linear measurement of the perimeter of the site adjoins parcels that are developed with urban uses. For the purposes of this definition, parcels that are only separated by a street or highway shall be considered to be adjoined."* The Ruby Meadow site is about 50% which is less than the required 75%.

Section 65589.5.

(a) (1) The Legislature finds and declares all of the following:

(A) The lack of housing, including emergency shelters, is a critical problem that threatens the economic, **environmental, and social quality of life** in California.

(D) Many local governments do not give adequate attention to the economic, **environmental**, and social costs of decisions that result in disapproval of housing development projects, reduction in density of housing projects, and excessive standards for housing development projects.

(A) California has a housing supply and affordability crisis of historic proportions. The consequences of failing to **effectively** and aggressively confront this crisis are hurting millions of Californians, robbing future generations of the chance to call California home, stifling economic opportunities for workers and businesses, worsening poverty and homelessness, and **undermining the state's environmental and climate objectives**.

(I) An additional consequence of the state's cumulative housing shortage is a significant increase in **greenhouse gas emissions** caused by the displacement and redirection of populations to states with greater housing opportunities, particularly working- and middle-class households. California's cumulative housing shortfall therefore has not only national but international environmental consequences.

(b) It is the policy of the state that a local government not reject or make infeasible housing development projects, including emergency shelters, that contribute to meeting the need determined pursuant to this article **without a thorough analysis** of the economic, social, and environmental effects of the action and without complying with subdivision (d).

(e) Nothing in this section shall be construed to relieve the local agency from complying with the **congestion management program** required by Chapter 2.6 (commencing with Section 65088) of

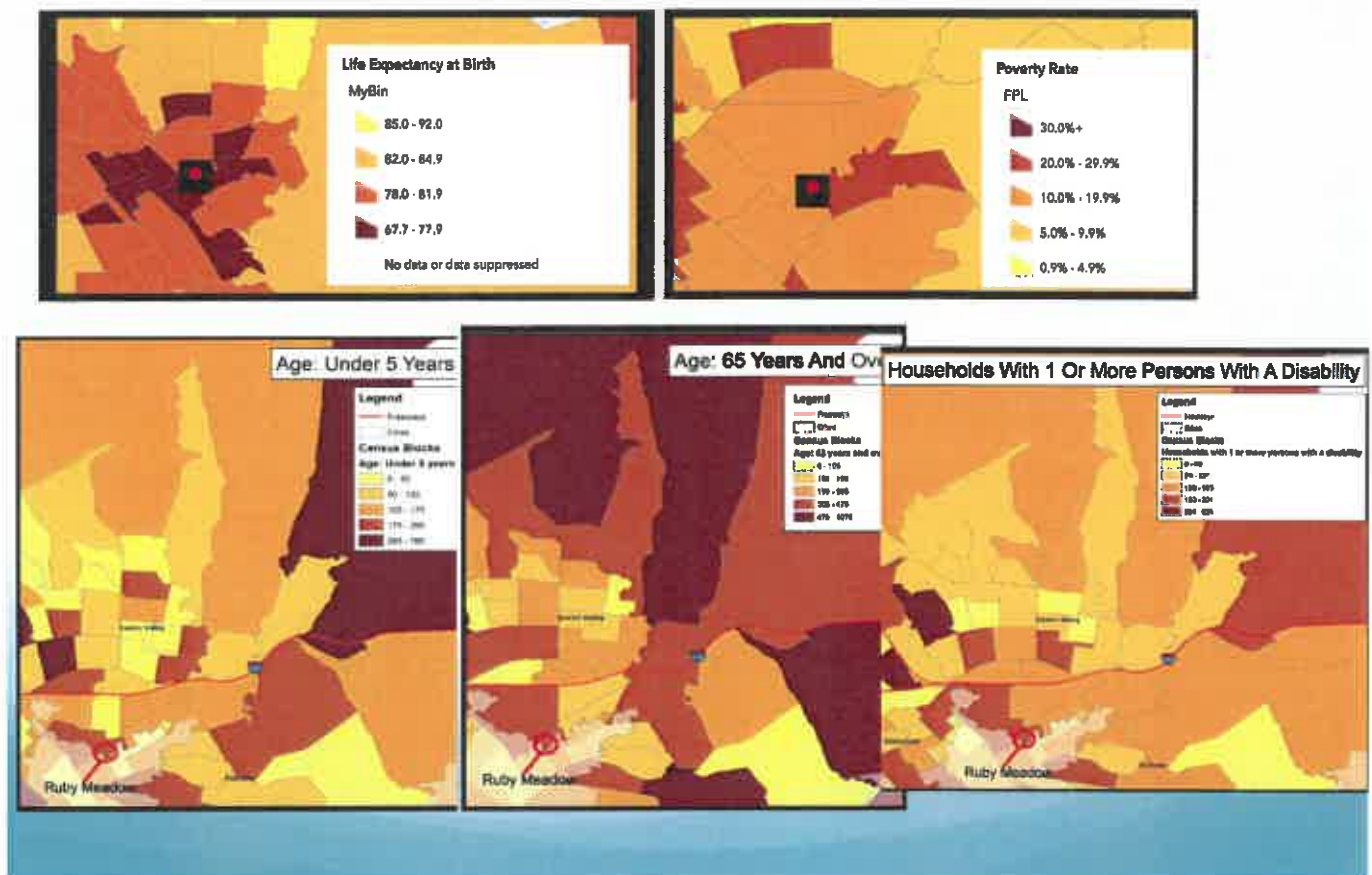
Division 1 of Title 7...or otherwise complying with the **California Environmental Quality Act** (Division 13 (commencing with Section 21000) of the Public Resources Code).

(1) "Feasible" means capable of being accomplished in a successful manner within a reasonable period of time, taking into account economic, **environmental, social,** and technological factors.

Environmental Justice Considerations

Alameda County demographics indicate our neighborhood includes approximately 3x the percentage of African Americans than the California State average, making the location an Environmental Justice Community. Other demographics show that we already have a high concentration of poverty, senior citizens, children, and people with disabilities. More than a thousand new units are planned in the immediate area when we are already at a park deficit. More development without added amenities or infrastructure is inappropriate and severely detrimental to the existing neighborhood.
