### **Conditions of Repetitive Trip Oversize/Overweight Move Permits**

---

All movements under this Permit shall be subject to the following conditions:

1. Moves are restricted to the specific route and times described on the face.
2. The wet-signed original Permit must be kept in the cab of the hauling, towing, or driven vehicle. A reprinted or faxed copy of this Permit is valid only for reference purposes and may not be used as an authorization to move.
3. Vehicles/vehicle combinations/loads of a different Haul/Drive/Tow classification than that described on the face are not authorized to move by this Permit.
4. Loaded or driven vehicles or vehicle combinations that exceed any of the loaded dimensions shown on the face are not authorized to move by this Permit.
5. Loaded or driven vehicles or vehicle combinations that exceed the number of axles shown on the face are not authorized to move by this Permit.
6. Loaded or driven vehicles or vehicle combinations with axle group loads that exceed the axle group loads shown on the face are not authorized to move by this Permit.
